No food or beverage may be sold from any booth without approval by the BPBA. Booth Spaces are NOT guaranteed from year to year, we will do our best to honor requests. This event is sponsored by Bemus Point Businesses, if there is too much overlap with any business, you may not be approved. All decisions by the BPBA Fall Fest Committee are final.

HOURS: Booths must be open Saturday & Sunday from 10 AM - 5 PM & Sun. from 10 AM - 5 PM. Friday will still be a free/bonus day, hours also being 10AM - 5PM. (NOTE – THESE ARE SUBJECT TO CHANGE – WE WILL KEEP ALL VENDORS UPDATED).

The village businesses will be kicking off the event on Friday the 13th, if you would like to set up and be in your booth on Friday, let us know. **FRIDAY will be FREE OF CHARGE!**

- The village businesses will be kicking off the event on Friday the 13th, if you would like to set up and be in your booth on Friday, **you must let us know. FRIDAY will be FREE OF CHARGE**
- Booth locations are NOT guaranteed from year to year. If you have a need or request, please indicate so on your application. Vendors attending all three days will be given priority locations. If you let us know that you are attending Friday, then choose not to do so, you will be relocated and may be asked not to return in the future.
- This is an outdoor show – **Vendors are responsible for supplying their own tent and tables. Booths fit standard 10' x 10' tents**
- We do not offer overnight security. You may leave up your tent/tables/merchandise, but you do so at your own risk.
- The collection and reporting of NYS tax is the responsibility of the Exhibitor.
- No food or beverage may be sold from any booth without approval by the BPBA.
- **SHOW HOURS: Booths must be open Sat. from 10 AM - 5 PM & Sun. from 10 AM – 5 PM.**
(NOTE – THESE ARE SUBJECT TO CHANGE – WE WILL KEEP ALL VENDORS UPDATED)
- This event is sponsored by Bemus Point Businesses, if there is too much overlap with any business, you may not be approved. All decisions by the BPBA Fall Fest Committee are final.
- If any vendor breaks contract/the requirements outlined in this agreement, they will not be invited back to future shows.

I understand and agree that neither Bemus Point Business Association nor the Village of Bemus Point, NY, its members and/or directors and officers may be held liable in any way for any occurrence in connection with my participation in the event that may result in injury, death, or other damages to me or my family, heirs, or assigns, and in consideration of being allowed to participate in this event, I hereby personally assume all risks in connection with said event for any harm, injury, or damage that may befall me, including all risks connected therewith, whether foreseen or unforeseen; and further to save and hold harmless said event and persons from any claim by me, or my family, estate, heirs, or assigns arising out of my participation in this event.
