This is an outdoor show – **Vendors are responsible for supplying their own tent and tables.** Electricity is limited, **if you require it, you must indicate so on your application.** The collection and reporting of NYS tax is the responsibility of the Exhibitor, **you must also provide copies of your food vending license/insurance.** All decisions by the BPBA Fall Fest Committee are final. **Food vendors – please bring your own trash can/bags.** We will be doing a nightly trash pickup during the event.

HOURS: You must be open Saturday & Sunday from 10 AM - 5 PM & Sun. from 10 AM - 5 PM.

- Food Vendors – Bring your own trash receptacles, we will have a trash pickup each evening after the event
- **SHOW HOURS: Booths must be open Sat. from 10 AM - 5 PM & Sun. from 10 AM – 5 PM.**
- If any vendor breaks contract/the requirements outlined in this agreement, they will not be invited back to future shows.

I further state that I am of lawful age and legally competent to sign this affirmation and release, or that I have acquired the written consent of my parents or guardians; that I understand the terms herein are contractual and not a mere recital; and that I have signed this document of my own free will.
